In consideration of my minor child, _____, being permitted to participate in a swim program at the Red Hawk Swim & Fitness Center, the undersigned, for myself, my spouse and on behalf of my minor children, release, waive, and covenant not to sue RED HAWK LAND COMPANY, LLC, its owners, members, managers, officers, directors, shareholders, allied entities, employees, or agents (collectively, "RED HAWK"), with respect to any and all claims or causes of action that I or my child may have or which may hereafter accrue to my child or me on account of injury to his/her person or property, whether caused by the negligence of RED HAWK or otherwise, as a result thereof.

This release is intended to discharge RED HAWK from all liability arising out of or connected in any way with my minor child's participation in the aquatic swim program at Red Hawk.
